- 1 The above consolidated and standalone unaudited financial results of Zaggle Prepaid Ocean Services Limited(formerly known as Zaggle Prepaid Ocean Services Private Limited) ('The Company') for the guarter ended June 30, 2024, were reviewed and recommended by the Audit Committee and approved by the Board of directors at their respective meeting held on July 30, 2024. The statutory auditors of the Company have carried out limited review of the above said results.
- 2 The consolidated and standalone unaudited financial results of the company have been prepared in accordance with the Indian Accounting Standards ('Ind AS') prescribed under Section 133 of the Companies Act, 2013 (the "Act") read with relevant rules issued thereunder, other accounting principles generally accepted in India and guidelines issued by the Securities and Exchange Board of India ("SEBI")
- 3 a. The consolidated unaudited financial results of quarter ended June 30, 2024, includes the results of the Associate Company Span Across IT Solutions Private Limited. (Associate w.e.f March 30.2024)
- b. The consolidated unaudited financial results of year ended March 31,2024 includes the results of the Wholly owned Subsidiary Company Zaggle Technologies Limited (subsidary till November 21, 2023)
- 4 During the year ended March 31, 2024, the Holding Company has completed its Initial Public Offer (IPO) of 3,43,52,255 equity shares of face value of ₹ 1 each at an issue price of ₹ 164 per equity share (including a share premium of ₹ 163 per share). The issue comprised of a fresh issue of 2,39,02,439 equity shares and offer for sale of 1,04,49,816 equity shares by the selling shareholders. The Holding Company had received an amount of ₹ 3,621.60 million (net off estimated offer expenses ₹ 298.40 million, including pre- IPO related estimated expenses) from proceeds of fresh issue of equity shares. Pursuant to the IPO, th equity shares of Holding Company were listed on National Stock Exchange of India Limited ("NSE") and on BSE Limited ("BSE") on September 22, 2023. The utilisation of the net proceeds is summarised as below:
