These shares shall rank *pari-pasu*, in all respects with existing Equity Shares of the Company. The Company has already received in-principle approval from BSE Limited and National Stock Exchange of India Limited ("Stock Exchanges") for Zaggle ESOP 2022.

Consequent to aforesaid allotment, the issued, subscribed and paid-up equity share capital of the Company stand increased from INR 12,26,06,799/- (consisting of 12,26,06,799 equity shares of face value of INR 1 each) to INR 12,28,35,933/- (consisting of 12,28,35,933 equity shares of face value of INR 1 each).
