No action(s) has been taken against the listed entity/ its promoters/ directors/ subsidiaries either by SEBI or by Stock Exchanges during the review period. Accordingly, no details were furnished in the above Table. However, we report the following observations.

1. During the review of compliance under Regulation 32 of the SEBI (LODR) Regulations, 2015, it was noted that the Statement of Deviation/Variation relating to the preferential issue of convertible warrants was not submitted to the Stock Exchanges for the quarters ended December 31, 2025 and March 31, 2026.

However, the listed entity has made the revised filing of integrated financial results-XBRL with the inclusion of the Statement of Deviation/Variation relating to the preferential issue of convertible warrants for the quarters ended December 31, 2025 and March 31, 2026 with Stock Exchanges on May 29, 2026.

*The listed entity contends that the lapse was rectified voluntarily and promptly. The listed entity further contends that no investor interest was prejudiced and the listed entity remains in compliance with Regulation 32 of the SEBI (LODR) Regulations, 2015*

2. During the review period, penalties were imposed by the listed entity on the basis of Penalty Matrix approved by the Board of Directors on certain designated persons and their immediate relatives of the listed entity for violation of SEBI (Prohibition of Insider Trading) Regulations, 2015. The listed entity has reported such violations related to Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and their Immediate Relatives under SEBI (Prohibition of Insider Trading) Regulations, 2015 pursuant to SEBI Circular No: SEBI/HO/ISD/ ISD/CIR/P/2020/135 dated July 23, 2020 read with SEBI/HO/GSD/TAD/P/ CIR/2023/149 dated September 4, 2023 to the Stock Exchanges during the review period.
